“Once in a Leap Year Giveaway” Official Rules

IMPORTANT! PLEASE CAREFULLY READ THESE “ONCE IN A LEAP YEAR GIVEAWAY” RULES (hereinafter, “GIVEAWAY Rules”) BEFORE ENTERING THE CIRCA RESORT & CASINO GIVEAWAY AS THESE RULES AFFECT YOUR LEGAL RIGHTS AND OBLIGATIONS.

Timing: The Giveaway shall start on February 1, 2024 at 9:00 a.m. Pacific Daylight Time (PDT) and all entries must be received by the Sponsor by 9:00 a.m. PDT on February 19, 2024, hereinafter, the “Giveaway Period”). The Sponsor shall not be responsible for lost, late, or misdirected entries, server unavailability, computer, any other electronic malfunction, or human error relating to this Giveaway and/or the use of short-code. All references to time of day refer to Las Vegas, Nevada, time.

The Prize: The one (1) selected Winner will receive one (1) “Once in a Leap Year Giveaway” package valid only at Circa Resort & Casino on Thursday, February 29, 2024 – Sunday, March 3, 2024.
