

Circa Resort & Casino Walk-Off Sweepstakes Rules

IMPORTANT! PLEASE CAREFULLY READ THESE GIVEAWAY RULES (hereinafter, "GIVEAWAY Rules") BEFORE ENTERING THE CIRCA RESORT & CASINO GIVEAWAY AS THESE RULES AFFECT YOUR LEGAL RIGHTS AND OBLIGATIONS.
