REV, WHITE & BLUE

AN ALL-AMERICAN TRUCK GIVEAWAY RULES

- 1. Rev, White & Blue All American Truck Promotional Giveaway ("Rev, White & Blue") is a joint casino promotion for patrons of Circa Resort & Casino, the D Las Vegas and Golden Gate Hotel & Casino. Rev, White & Blue runs from December 1, 2025 until July 5, 2026 with six (6) monthly qualifier drawings. One (1) drawing will take place on the last Friday of each month December May. The qualifier earning period begins on December 1, 2025 at 12:00AM and ends on May 29, 2026 at 6:30PM. The grand prize giveaways will be three (3) unique vehicles: Ford F150, Chevrolet Silverado, and Ram 1500 ("Unique Vehicles"). One vehicle will be selected on July 3, 2026, July 4, 2026 and July 5, 2026. In order to participate and win, patrons must be a Club One® member ("Participants"). The winning Participant must be present at the final drawing(s) to win and claim their choice of vehicle as they are made available.
