RULES

At Par Promotion (the "Promotion") is a Circa Resort & Casino, the D Las Vegas and Golden Gate Hotel & Casino ("Properties") promotion taking place beginning Friday February 6, 2026 and will end on Monday, August 31, 2026. Patrons with a Canadian identification will have an opportunity to receive the rate of the US dollar in exchange for their Canadian dollar in slot promotional funds.

1. The Promotion will take place at all three Properties.
 2. Patrons can participate in the Promotion at all Properties.
 3. Patrons can only exchange their Canadian dollars for slot promotional funds in US dollars for a one-time redemption at the property of their choice.
 4. Patrons may insert their Club One player's card with their slot promotional funds at each property's following machines:
 - a. **Circa Resort & Casino** – all slot machines excluding electronic table games and wide area progressives
 - b. **the D Las Vegas** – all slot machines excluding electronic table games and wide area progressives
 - c. **Golden Gate Hotel & Casino** – all slot machines excluding electronic table games, video poker and wide area progressives
 5. Patrons must be Club One members to participate in the Promotion.
 6. Club One Membership is free.
 7. Patrons who provide a Canadian identification (Canadian government ID, Canadian driver's license, Canadian passport) to any of the Properties will receive slot promotional funds of 1 US dollar for every Canadian dollar regardless of the exchange rate loaded on their Club One player's card to be used at any of the three properties.
 8. Upon visiting the Club One desk at the property of choice, and provide their Canadian identification, the patron will receive a confirmation voucher of identification where the patron will then take to the Cage Department.
 9. The Cage Department will process the Canadian patron's transaction and then notify Club One to load the slot promotional funds based on the amount of the transaction in USD.
 10. On a daily basis, the Property's Cage Department will provide the patron with the Canadian rate and US rate in dollars based from xe.com. The rate will be determined by the closing rate of the previous business day (example: June 4th closing rate will be the rate used for June 5th). That rate will remain in effect for the entire day. (Example US Dollar Rate of \$.72 to the Canadian Dollar Rate of \$1.00). For every Canadian dollar given to the casino cage, the Cage Department will provide Club One the exchange rate.
 11. Canadian patrons can exchange their Canadian dollar for slot promotional funds in US dollars up to a maximum of \$500.00 Canadian dollars loaded onto the Canadian patron's Club One player's Card.
 12. Loaded slot promotional funds are non-transferable and hold no cash value.
 13. A Canadian patron will have seventy-two (72) hours from the day of issuance to play through their slot promotional funds.
 14. Must be 21 years of age or older to participate in this Promotion.
 15. By participating in this promotion, participants give their permission to Circa Resort & Casino, the D Las Vegas and Golden Gate Hotel & Casino to use their names, photographs, likeness, etc., for promotional purposes.
 16. Employees of Circa Resort & Casino, the D Las Vegas or the Golden Gate Hotel & Casino or their affiliates are not eligible to participate in this Promotion.
 17. Management reserves all rights to modify or cancel the Promotion at any time without notice. All disputes shall be settled by management, in their sole and absolute discretion, and management shall be the sole and final judge of any disputes.
